**ABOUT THE 128 BUSINESS COUNCIL:**

In 1985, three organizations — GTE Laboratories, Polaroid, and The Nelson Companies — joined together and funded a study of the Route 128 West area between Route 2 and Route 20. The study concluded that gridlock conditions would affect the Route 128 West region if strategies to reduce congestion and increase transportation options were not put in place. The 128 Business Council is a non-profit public/private partnership that was formed to help reduce traffic congestion on Route 128 West by providing alternative transportation services and information.

The Council also works with state and federal transportation agencies on behalf of member businesses. The Council is funded by member companies that are committed to the economic vitality of the Route 128 West area, now expanded to include the region from Woburn to Needham. In 2015, the 128 Business Council continues to provide important alternative transportation services and information for its member companies, in addition to serving as a source for sustainability education and services.

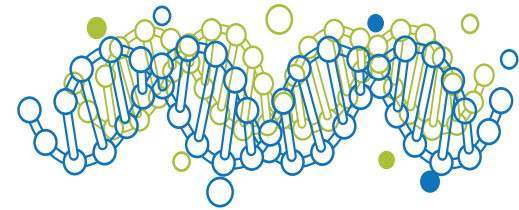


- All arrival times are approximate. Please arrive at stop at least 5 minutes before listed time.
